The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

## I. Subject Property

16 As described in detail in Tulalip Tribes Police Department Incident Report #24-0266, which is on file with the Tulalip Tribal Court under this cause number, on or about the 31st 18 day of January, 2024, Tulalip Tribes Police Department (TTPD) seized a \$6,902 from Shatandah Bomber in the vicinity of 6221 31st Avenue NE, Tulalip, WA 98271 in connection 19 with narcotic trafficking on the Tulalip Reservation.

## **II. AUTHORITY**

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).
