COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #19-0748, which is on file with the Tulalip Tribal Court under this cause number, on or about the 8th day of March, 2019, Tulalip Tribal Police (TPD) seized a 2007 Jeep Compass & VIN #1J8FT57W47D261457 from Jose Morales Solorio (driver) and Krista Geesman (registered owner) in the vicinity of 6410 33rd Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).



III. 1 **CLAIMANTS** Jose Morales Solorio, driver, from whom the subject property was seized and the 2 registered owner of the vehicle, Krista Geesman, are the only people who the Tribes knows or 3 has reason to believe has or may asset a claim to the subject property. Jose Morales Solores is 4 believed to reside at 8332 11th Drive West, Apt. A, Everett, Washington 98204 (Police Report). 5 Krista Geesman is believed to reside at 4011 108th Street SE, Everett, Washington 98208 (Police 6 Report). 7 IV.
