COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #19-4127, which is on file with the Tulalip Tribal Court under this cause number, on or about the 23rd day of November, 2019. Tulalip Tribal Police (TPD) seized a 2009 Audi A4 VIN # WAULF78K39N039026 from Justin Hawley (driver/registered owner) in the vicinity of 8924 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

AUTHORITY II.

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).



1	III. CLAIMANTS
2	Justin Hawley, driver/registered owner/legal owner from whom the subject property was
3	seized, the registered owner of the vehicle, is the only person who the Tribes knows or has reason
4	to believe has or may asset a claim to the subject property. Justin Hawley is believed to reside
5	at 11616 32 nd Street NE, Lake Stevens, Washington 98258 (Police Report).
6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Justin Hawley answer the allegations of this Petition, and, ultimately, for the Court to
9	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
