COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

## I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #19-0342, which is on file with the Tulalip Tribal Court under this cause number, on or about the 29<sup>th</sup> day of January, 2019, Tulalip Tribal Police (TPD) seized a 2016 Mercedes Benz VIN# WDDHF8JB2GB302216 from Keynan Newsham (driver) in the vicinity of 10200 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

## II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

1	III. CLAIMANTS
2	Keynan Newsham, driver, from whom the subject property was seized, the registered
3	owner of the vehicle, Adam Schneider, and the legal owner of the vehicle, Daimler Title Co.
4	are the only people who the Tribes knows or has reason to believe has or may asset a claim to
5	the subject property. Keynan Newsham is believed to reside at 13203 NE 138 <sup>th</sup> Place, Kirkland
6	Washington 98033 (Police Report), Adam Schneider is believed to reside at 4525 164 <sup>th</sup> Stree
7	SW, Lynnwood, Washington 98087, and Daimler Title Co. is located at P.O. Box 997545
8	Sacramento, California 95899.
9	IV. CONCLUSION
10	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
11	to have Keynan Newsham, Adam Schneider, and Daimler Title Co. answer the allegations of
12	this Petition, and, ultimately, for the Court to order that the Subject Property be forfeited for the
13	benefit of the Tulalip Tribes.
