COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-1739, which is on file with the Tulalip Tribal Court under this cause number, on or about the 2nd day of July, 2021, Tulalip Tribal Police (TPD) seized a 2001 Mercedes-Benz S Class & VIN # WDBNG75J51A188696 from Lindsey Richards (driver/legal owner) in the vicinity of 6221 31st Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

1 III. **CLAIMANTS** Lindsey Richards, legal owner, from whom the subject property was seized, is the only 2 people who the Tribes knows or has reason to believe has or may asset a claim to the subject 3 property. Lindsey Richards is believed to reside at 9201 11th Place NE, Unit B, Lake Stevens, 4 Washington 98258 (Police Report). 5 6 IV.
