The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #19-3695, which is on file with the Tulalip Tribal Court under this cause number, on or about the 15th day of October, 2019, Tulalip Tribal Police (TPD) seized a \$2,470 from Ariette Cheer in the vicinity of 2300 block of Marine Drive NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).



1	III. CLAIMANTS
2	Ariette Cheer, from whom the subject property was seized, is the only person who the
3	Tribes knows or has reason to believe has or may assert a claim to the subject property. Ariette
4	Cheer is believed to be residing at 4200 76th Place NW, Tulalip, Washington 98271 (Police
5	Report).
6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Ariette Cheer answer the allegations of this Petition, and, ultimately, for the Court to
9	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
