The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

## I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #19-2584, which is on file with the Tulalip Tribal Court under this cause number, on or about the 15<sup>th</sup> day of August, 2019, Tulalip Tribal Police (TPD) seized a \$375 from Annette Cheer in the vicinity of 88<sup>th</sup> Street NE and 27<sup>th</sup> Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

## II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).



1	III. CLAIMANTS
2	Annette Cheer, from whom the subject property was seized, is the only person who the
3	Tribes knows or has reason to believe has or may assert a claim to the subject property. Annette
4	Cheer is believed to be residing at 2611 Joseph Charles Jr. Loop Road, Tulalip, Washington
5	98271 (Police Report).
6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Annette Cheer answer the allegations of this Petition, and, ultimately, for the Court to
9	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
