COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #20-2013, which is on file with the Tulalip Tribal Court under this cause number, on or about the 20th day of August, 2020, Tulalip Tribal Police (TPD) seized \$85 from Emanuel Holliday in the vicinity of 6410 33rd Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

1	III. CLAIMANTS
2	Emanuel Holliday, from whom the subject property was seized, is the only person who
3	the Tribes knows or has reason to believe has or may assert a claim to the subject property.
4	Emanuel Holliday is believed to be housed at the Department of Corrections facility in Thurston
5	County, Washington at 7345 Linderson Way SW, Tumwater, WA 98501 (Booking Report) and
6	his last known address where he is residing at is 108 8th Street SE, Auburn, WA 98071 (Police
7	Report).
8	IV. CONCLUSION
9	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
10	to have Emanuel answer the allegations of this Petition, and, ultimately, for the Court to order
11	that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
