I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #20-3108, which is on file with the Tulalip Tribal Court under this cause number, on or about the 15th day of December, 2020, Tulalip Tribal Police (TPD) seized a 2010 Chevrolet Malibu & VIN #1G1ZC5EB1AF156481 from Chaniah Anderson (registered owner) in the vicinity of 10600 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(10).
