I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #19-4345, which is on file with the Tulalip Tribal Court under this cause number, on or about the 13th day of December, 2020, Tulalip Tribal Police (TPD) seized \$4,235 from Sha-Nee-Nia Spencer in the vicinity of 8100 block of 27th Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

1	III. CLAIMANTS
2	Sha-Nee-Nia Spencer, from whom the subject property was seized, is the only person
3	who the Tribes knows or has reason to believe has or may assert a claim to the subject property.
4	Sha- Nee-Nia Spencer is believed to be residing at 8021 30th Drive NE, Tulalip, Washington
5	98271 (Police Report).
6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Sha-Nee-Nia Spencer answer the allegations of this Petition, and, ultimately, for the
9	Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
