COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

#### I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #22-1292, which is on file with the Tulalip Tribal Court under this cause number, on or about the 5th day of May, 2022, Tulalip Tribal Police (TPD) seized a 2005 Ford Mustang & VIN #1ZVHT82H355188418 from Daniel Schlemmer (driver) in the vicinity of 6221 31st Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

#### H. **AUTHORITY**

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

### III. CLAIMANTS

Daniel Schlemmer is believed to reside at 323 1st Street, Gold Bar, Washington 98251 (JIS). Doreen Carr is believed to reside at 650 Duvall Avenue NE, Apt. F624, Renton, Washington 98059 (Police Report).

## IV. CONCLUSION

Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons to have Daniel Schlemmer and Doreen Carr answer the allegations of this Petition, and, ultimately, for the Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
