COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #20-0329, which is on file with the Tulalip Tribal Court under this cause number, on or about the 4th day of February, 2020, Tulalip Tribal Police (TPD) seized a 1999 Honda Civic & VIN # JHMEJ8642XS000140 from Leon Garcia Rojas (driver/registered owner) in the vicinity of 6410 33rd Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).



1	III. CLAIMANTS
2	Leon Garcia Rojas, driver, from whom the subject property was seized, is the registered
3	owner/legal owner of the vehicle, and is the only person who the Tribes knows or has reason to
4	believe has or may asset a claim to the subject property. Leon Garcia Rojas is believed to reside
5	at 1811 Chestnut Street, Apt. 304, Everett, Washington 98201 and 1231 South Broadway,
6	Everett, Washington 98201 (Police Report).
7	IV. CONCLUSION
8	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
9	to have Leon Garcia Rojas answer the allegations of this Petition, and, ultimately, for the Court
10	to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
