COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #20-0511, which is on file with the Tulalip Tribal Court under this cause number, on or about the 22nd day of February, 2020, Tulalip Tribal Police (TPD) seized a \$388 from Stacey Sebastiani in the vicinity of 2624 Marine Drive NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. **AUTHORITY**

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

3	the Tribes knows or has reason to believe has or may assert a claim to the subject property.

6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Stacey Sebastiani answer the allegations of this Petition, and, ultimately, for the Court
9	to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
