COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-0319, which is on file with the Tulalip Tribal Court under this cause number, on or about the 7th day of February, 2021, Tulalip Tribal Police (TPD) seized a 2006 Acura TSX & VIN # JH4CL96936C034454 from Sheri Deraimo (driver/legal owner) in the vicinity of 6221 31st Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

1	III. CLAIMANTS
2	Sheri Deraimo, driver/legal owner, from whom the subject property was seized, is the
3	only people who the Tribes knows or has reason to believe has or may asset a claim to the subject
4	property. Sheri Deraimo is believed to reside at 1127 N. Garden Street, Bellingham, Washington
5	98225 (Police Report). Sheri Deraimo is believed to reside at 4015 Eliza Avenue Trlr 83,
6	Bellingham, Washington 98226 (Police Report).
7	IV. CONCLUSION
8	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
9	to have Sheri Deraimo answer the allegations of this Petition, and, ultimately, for the Court to
10	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
