PETITION FOR FORFEITURE OF SEIZED PROPERTY

COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-0074, which is on file with the Tulalip Tribal Court under this cause number, on or about the 10th day of January, 2021, Tulalip Tribal Police (TPD) seized a 2006 Honda Accord & VIN #1HGCM655X6A032869 from Daniel Bock (driver/registered owner) in the vicinity of 10200 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

1	III. CLAIMANTS
2	Daniel Bock, driver/registered owner, from whom the subject property was seized and
3	the legal owner of the vehicle, Western Funding Inc., are the only people who the Tribes knows
4	or has reason to believe has or may asset a claim to the subject property. Daniel Bock is believed
5	to reside at 2013 Harksell Road, Ferndale, Washington 98248 (Police Report). Western Funding
6	Inc., is believed to have a mailing address of P.O. Box 278897, Sacramento, California 95827
7	(Police Report).
8	IV. CONCLUSION
9	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
10	to have Daniel Bock and Western Funding Inc. answer the allegations of this Petition, and,
11	ultimately, for the Court to order that the Subject Property be forfeited for the benefit of the
12	Tulalip Tribes.
