COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #22-2719, which is on file with the Tulalip Tribal Court under this cause number, on or about the 16th day of September, 2022, Tulalip Tribal Police (TPD) seized a 2008 Audi A5 & VIN # WAUDK78T68A032604 from Darryl Freeman (driver) in the vicinity of 906 Marine Drive, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).



1	III. CLAIMANTS
2	Darryl Freeman, driver, from whom the subject property was seized and the legal owner
3	of the vehicle, Carlos Diaz (legal owner) are the only people who the Tribes knows or has reason
4	to believe has or may asset a claim to the subject property. Darryl Freeman is believed to reside
5	at 3935 High Street, Everett, Washington 98201 (Police Report). Carlos Diaz is believed to
6	reside at 1411 S. Concord Street, Apt. 2, Seattle, Washington 98108 (Police Report).
7	IV. CONCLUSION
8	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
9	to have Darryl Freeman and Carlos Diaz answer the allegations of this Petition, and, ultimately
10	for the Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes
