The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

SUBJECT PROPERTY I.

As described in detail in Tulalip Police Incident Report #22-2719, which is on file with the Tulalip Tribal Court under this cause number, on or about the 16th day of September, 2022. Tulalip Tribal Police (TPD) seized \$20,108.59 from Darryl Freeman in the vicinity of 906 Marine Drive, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. **AUTHORITY**

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

1	III. CLAIMANTS
2	Darryl Freeman, from whom the subject property was seized, is the only person who the
3	Tribes knows or has reason to believe has or may assert a claim to the subject property. Darryl
4	Freeman is believed to be residing at 3935 High Street, Everett, Washington 98201 (Police
5	Report).
6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Darryl Freeman answer the allegations of this Petition, and, ultimately, for the Court to
9	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
