The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #22-3302, 15 which is on file with the Tulalip Tribal Court under this cause number, on or about the 10th 16 day of November, 2022, Tulalip Tribes Police Department (TTPD) seized a \$6,145 cash from 17 Casey Paul Landis in the vicinity of 6325 31st Avenue NE, Tulalip, WA 98271 in connection with narcotics trafficking on the Tulalip Reservation. 18

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

III. Claimants

Casey Landis, from whom the subject property was seized, is the only person who the Tribes knows or has reason to believe has or may assert a claim to the subject property. Mr. Landis is believed to reside at 302 Willow Court North, Bellingham, Washington 98226.
