The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

# I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-0557, which is on file with the Tulalip Tribal Court under this cause number, on or about the 4<sup>th</sup> day of March, 2021, Tulalip Tribal Police (TPD) seized a \$1,290 from Dakota Devalkeneer in the vicinity of 3708 88<sup>th</sup> Street NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

### II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.0208(7).

## III. CLAIMANTS

Dakota Devalkeneer, from whom the subject property was seized, is the only person who the Tribes knows or has reason to believe has or may assert a claim to the subject property.
