COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #20-2015, which is on file with the Tulalip Tribal Court under this cause number, on or about the 3rd day of September, 2020, Tulalip Tribal Police (TPD) seized a 1995 Jeep Cherokee & VIN #1J4GZ58S1SC628085 from Brian Martin (driver) and Tina Wagner (registered owner) in the vicinity of 515 54th Street NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

1	III. CLAIMANTS
2	Brian Martin, driver, from whom the subject property was seized, the registered owner
3	of the vehicle, Tina Wagner, are the only people who the Tribes knows or has reason to believe
4	has or may asset a claim to the subject property. Brian Martin is believed to reside at 13519
5	Cascadian Way, Tulalip, Washington 98271 (Police Report). Tina Wagner is believed to reside
6	at 4414 125th Street NE, Marysville, Washington 98271 (Police Report).
7	IV. CONCLUSION
8	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
9	to have Brian Martin and Tina Wagner answer the allegations of this Petition, and, ultimately,
10	for the Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
