# PETITION FOR FORFEITURE OF SEIZED PROPERTY

COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

#### I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #22-2684, which is on file with the Tulalip Tribal Court under this cause number, on or about the 13<sup>th</sup> day of September, 2022, Tulalip Tribal Police (TPD) seized a 2014 Jeep Grand Cherokee & VIN #1C4RJFDJ7EC279768 from Andy Vongdala (driver) in the vicinity of 10200 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

#### II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

### III. CLAIMANTS

Andy Vongdala, driver, from whom the subject property was seized and the legal owner of the vehicle, Verdant Auto Sales, are the only people who the Tribes knows or has reason to believe has or may asset a claim to the subject property. Andy Vongdala is believed to reside at 1010 S. 312<sup>th</sup> Street, Apartment 321, Federal Way, Washington 98003 or 11429 Military Road S., Apartment 5, Seattle, Washington 98168 (Police Report). Verdant Auto Sales has a mailing address of 1516 Auburn Way North, Auburn, Washington 98002 (Police Report).

#### IV. CONCLUSION

Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons to have Andy Vongdala and Verdant Auto Sales answer the allegations of this Petition, and, ultimately, for the Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
