SUBJECT PROPERTY I.

COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to

As described in detail in Tulalip Police Incident Report #22-0685, which is on file with the Tulalip Tribal Court under this cause number, on or about the 9th day of March, 2022, Tulalip Tribal Police (TPD) seized a 2017 Honda Accord, VIN #1HGCR2F31HA177082 from Stephanie Ketchum (driver/legal owner) in the vicinity of 3400 block of Marine Drive, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. **AUTHORITY**

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).



1	III. CLAIMANTS
2	Stephanie Ketchum, driver/legal owner, from whom the subject property was seized, is
3	the only person who the Tribes knows or has reason to believe has or may asset a claim to the
4	subject property. Stephanie Ketchum is believed to reside at 6509 58th Avenue NE, Marysville,
5	Washington 98270 (Police Report).
6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Stephanie Ketchum answer the allegations of this Petition, and, ultimately, for the Court
9	to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
