As described in detail in Tulalip Police Incident Report #21-0450, which is on file with the Tulalip Tribal Court under this cause number, on or about the 22nd day of February, 2021, Tulalip Tribal Police (TPD) seized a \$2,307 from Joanna Mosher in the vicinity of 10200 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

1	III. CLAIMANTS
2	Joanna Mosher, from whom the subject property was seized, is the only person who the
3	Tribes knows or has reason to believe has or may assert a claim to the subject property. Joanna
4	Mosher is believed to be residing at 2507 Broadway, Everett, Washington 98201 (Police Report).
5	IV. CONCLUSION
6	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
7	to have Joanna Mosher answer the allegations of this Petition, and, ultimately, for the Court to
8	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
