The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #25-3162, which is on file with the Tulalip Tribal Court under this cause number, on or about the 29th day of October, 2025, Tulalip Tribes Police Department (TTPD) seized a \$1,075 dollars in U.S. Currency from Xochitl Ochoa in the vicinity of 5900 block of Mission Beach Road, Tulalip, Washington 98271 in connection with narcotic trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).
