

Marriage License Application Instructions and Form

| Step 1 | Get the marriage license application form from either: |

| | In-person from a Court Clerk at Tulalip Tribal Court, or Online via Tulalip Tribal Court website (www.tulaliptribalcourt-nsn.gov) under "Forms and Filings." |
| Step 2 | Complete the application form and sign it in front of a notary . There is a notary public at the court. |
| | NOTE: The affidavits for both applicants are located on the same single page form. NOTE: All forms must be filled out in black or blue ink, contain original signatures, and be notarized by a notary public – NO faxed signatures. |
| Step 3 | Return completed application form and pay \$100 fee in-person at Tulalip Tribal Court. |
| Step 4 | Clerk will process the application, please allow 1 business day to process. Pick up the following documents from the Court Clerk: |
| | Marriage License: gives the person performing the ceremony authority to marry. The Court Clerk will fill this out. Certificate of Marriage from Tulalip: certifies that a marriage was performed. You will fill this out and return it to the Clerk. The officiant's signature is needed. Certificate of Marriage from Washington State: certifies that a marriage was performed for Washington State public health records. You will fill this out and return it to the Clerk. The officiant's signature is needed. |

• NOTE: If you are requesting return copies <u>by mail</u>, you must provide a self-addressed, stamped envelope, and allow 30 days for processing and return. License will not be mailed without a return envelope, and are deposited in the US mail at the licensee's risk.
