COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

#### I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #19-3678, which is on file with the Tulalip Tribal Court under this cause number, on or about the 14<sup>th</sup> day of October, 2019, Tulalip Tribal Police (TPD) seized a Glock Model 19 – 9mm, serial #BEYW252, (hereinafter "Subject Firearm") in the vicinity of the 7506 Ezra Hatch Road, Unit A, Tulalip, Washington in connection with the commission of any Class F crime as defined by Tulalip Tribal Code, on the Tulalip Reservation.

### II. AUTHORITY

Because the Subject Firearm was used or intended to be used, in any manner or part, or to facilitate, the commission of any Class F crime in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020(10).



1	III. CLAIMANTS
2	Keaden Posey, from whom the subject property was seized, is the only person who the
3	Tribes knows or has reason to believe has or may assert a claim to the subject property. He is
4	believed to reside at 7506 Ezra Hatch Road, Unite A, Tulalip, Washington 98271 (Police
5	Report).
6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Keaden Posey answer the allegations of this Petition, and, ultimately, for the Court to
9	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes
