I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #18-3106, which is on file with the Tulalip Tribal Court under this cause number, on or about the 11th day of October, 2018, Tulalip Tribal Police (TPD) seized a \$1,011.48 from David Brewster in the vicinity of 6800 block of 14th Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

1	III. CLAIMANTS
2	David Brewster, from whom the subject property was seized, is the only person who the
3	Tribes knows or has reason to believe has or may assert a claim to the subject property. He is
4	believed to reside at 5105 2 nd Avenue NE, Marysville, Washington 98270 (Police Report).
5	IV. CONCLUSION
6	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
7	to have David Brewster answer the allegations of this Petition, and, ultimately, for the Court to
8	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
