

# Marriage License Instructions and From

- Step 1: Obtain a blood test for venereal disease within 30 days of making application for marriage license. Blood test results must be provided to the Tulalip Tribal Court Specialist prior to issuance of the license or she or he files an affidavit attesting to the fact that she or he is free of venereal disease. The affidavit shall be presented to the Court Specialist before any license is issued.
- Step 2: Obtain the marriage license application form from the Tulalip Tribal Court Specialist or Tulalip Tribal Court Forms.
- Step 3: Complete the marriage application form, and sign it in form of a notary public. NOTE: the affidavits for both male and female applicants are located on a single page form. Any applicant who is younger than 18 years must obtain the notarized written consent of his/her parent or guardian to marry. All affidavits must be notarized.
- Step 4: Return application form with applicable fees and blood test results to:

All forms must be filled out in black or blue ink, contain original signatures and be notarized by a notary public-no faxed signatures.

Step 5: Pick up your license from the Court Specialist. We recommend you call ahead to see whether the license has been approved. If you are requesting a return copy by mail, you must provide self-addressed, stamped envelope, and allow 30 days for processing and return. License will not be mailed without a return envelope, and are deposited in the US mails at the licensee's risk.
