

AUTHORITY 23 Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed 24 chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is

subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

	to have Xochitl Ochoa answer the allegations of this Petition, and, ultimately, for the Court to
7	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
