The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #25-2122, which is on file with the Tulalip Tribal Court under this cause number, on or about the 18th day of July, 2025, Tulalip Tribes Police Department (TTPD) seized a \$2,825 US Dollars from Delma Kidd in the vicinity of 9324 Quil Ceda Blvd., Tulalip, WA 98271 in connection with narcotic trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

1	III. Claimants
2	Delma Kidd, Claimant, is a person who the Tribes knows or has reason to believe has
3	or may asset a claim to the subject property. Delma Kidd is believed to reside 2119 3rd

6	IV. CONCLUSION
7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Delma Kidd answer the allegations of this Petition, and, ultimately, for the Court to
9	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
