COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

## I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #25-2091, which is on file with the Tulalip Tribal Court under this cause number, on or about the 17<sup>th</sup> day of July, 2025, Tulalip Tribes Police Department (TTPD) seized a \$8,136 US Dollars and \$89 Canadian Dollars from Jason Daniel Doherty in the vicinity of 10200 Quil Ceda Blvd. in connection with narcotic trafficking on the Tulalip Reservation.

## II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

2	III. Claimants
3	Jason Daniel Doherty, Claimant, is a person who the Tribes knows or has reason to
4	believe has or may asset a claim to the subject property. Jason Daniel Doherty is believed to

7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Jason Daniel Doherty answer the allegations of this Petition, and, ultimately, for the
