As described in detail in Tulalip Tribes Police Department Incident Report #25-0872, which is on file with the Tulalip Tribal Court under this cause number, on or about the 3rd day of April, 2025, Tulalip Tribes Police Department (TTPD) seized a Polymer 80 9mm firearm (ghost gun), unknown serial number from Marvin JamesPangelinan, Jr. in the vicinity of 1712 98th Street NW Tulalip, WA 98271 in connection with narcotic trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Firearm was used or was intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeit pursuant to Tulalip Tribal Code 2.60.020§(9).
