The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law. 15

## I. Subject Property

16 As described in detail in Tulalip Tribes Police Department Incident Report #25-0931, 17 which is on file with the Tulalip Tribal Court under this cause number, on or about the 1st day 18 of April, 2025, Tulalip Tribes Police Department (TTPD) seized a Taurus G3c 9mm, serial #ACJ293406 from Desmond Lloyd in the vicinity of 10200 Quil Ceda Blvd., Tulalip, WA 98271 as a prohibited weapon that was unlawfully carried by Desmond Lloyd for concealing a 20firearm without a permit and with narcotic trafficking on the Tulalip Reservation.

## **II. AUTHORITY**

Because the Subject Firearm was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(9).
